Juvenes Pro Medicina Conference regulations

Due to the COVID-19 pandemic, the 60th Polish and 18th International Training & Scientific Conference *Juvenes Pro Medicina* 2022 is organized in accordance with applicable public health restrictions, allowing participants to present their work on the University campus or online. In line with the evolution of the COVID-19 pandemic in Poland, the Rules of the Juvenes Pro Medicina Conference may change.

I. General Regulations

- The 60th Polish and 18th International Training & Scientific Conference of Students' Scientific Societies and Junior Doctors *Juvenes Pro Medicina* will be held from the 12th to the 15th of May 2022. The event will be organized within the Didactic Center of the Medical University of Lodz (Pomorska Street 251, Lodz, Poland).
- 2. The Conference is organized by the Students' Scientific Association of the Medical University of Lodz (referred to as STN *in.pol. Studenckie Towarzystwo Naukowe*) and FUMED The Foundation of the Medical University of Lodz.
- 3. The Conference will be held in a hybrid form, which means that it will be possible to take part in it on-site or on-line.
- 4. The President of the Students' Scientific Association of the Medical University of Lodz appoints an IT Emergency team, whose main tasks will be to train, organize, and assist the Coordinators of Scientific Sessions in holding the on-line video communication within each Session.
- 5. The President of the Organizing Committee appoints Coordinators of Scientific Sessions, whose main tasks will be to organize, prepare, and supervise thematic sessions of the Conference.
- 6. The official website of the conference is http://jpm.umed.pl, all of the Participants are requested to visit: Juvenes Pro Medicina 2022 Facebook event. We encourage you to follow the updates on the Facebook page, where all information will be posted.
- 7. The official language of the Conference is English.
- 8. The condition for participation in the Conference is to have a certificate of complete Sars-CoV-2 vaccination.

II. The general course of the Conference.

- 1. The Conference consists of three parts: Scientific Sessions, Workshops, and Lecture Session.
- 2. The Scientific Sessions are divided into two sections: Original Research Sessions and Case Study Sessions.
- 3. Original Research Sessions will be organized in the form of on-site presentations. On-line participation in the Original Research Session is possible only for foreign participants or in case of a positive Sars-CoV-2 test result of the participant. The Conference will hold following Original Research Sessions: Basic Science, Cardiology, Cardiac Surgery and Interventional Cardiology, Dentistry, Dermatology, Endocrinology and Diabetology, Gynecology and Obstetrics, Internal Medicine, Neurology and Neurosurgery, Oncology and Hematology, Ophthalmology and Optometry, Orthopedics, Otolaryngology, Physiotherapy, Pediatrics, Pharmacy, Psychiatry and Psychology, Radiology and Nuclear Medicine, Surgery and Transplantology, Nephrology and Urology, Immunology and Allergology, Human Science in Medicine, Technical Medicine and Bioengineering.
- 4. The Plenary Session of the Conference includes best oral presentations (first places) from Original Research Sessions.
- Case Study Sessions will be organized in the form of on-line presentation. The Conference will hold following Case Study Sessions: Internal medicine, Surgery, Pediatrics and Oncology.

- 6. Minimum number of active participants with presentations required for the session's opening is 5. Otherwise, Organizers may decide to join two sessions which are thematically similar or do not open the session. In cases when the number of presentations presented during the thematic session is smaller than 5 (due to absence of the participants with approved abstracts or other unspecified reasons), the number of prizes awarded in the session may be decreased adequately.
- 7. Maximum number of presentations in one session is 12 for all Original Research Sessions. For the Case study session the maximum number of presentations in one session is 24. This is the maximum number of abstracts that can be approved for participation within the session. Organizers restrict the possibility to change the number of the maximum number of abstracts approved for a specific session.
- 8. The list of sessions from §2.3 can be changed, depending on the number and quality of registered papers from specific scientific areas.
- 9. The Plenary Session of the Conference includes best oral presentations (first places) from Original Research Sessions. The participants may present their study outcomes once again and compete for special prizes. The sponsor of the main plenary session award is FUMED The Foundation of Medical University of Lodz.
- 10. PhD Session is an additional session addressed to PhD students, who have not yet defended themselves. This session does not take part in the main Scientific Competition and the winner of this session does not take part in the Plenary Session Maximum number of presentations presented during PhD Session is 15. Minimum number of active participants with presentations required for the session's opening is 5.
- 11. The distinguished abstracts which have not been included in other sessions will have the opportunity to be presented at the **Poster Session**. Participation in this session is possible only on-site. Maximum number of presentations presented during Poster Session is 20. Winners do not take part in the Plenary Session.
- 12. The Workshops will be organized by the STN, Partners or Sponsors. Workshops will be held only on-site. Panels will be held on-line. Registration will be required to take part in the workshops. The number of participants in each workshop and panel is limited. Participation in the training part of the Conference is involved in conference fee.
- 13. The Lecture Session of the Conference should be understood as a series of lectures "Medicina Pro Juvenes". The aim of these lectures is to provide the attendees with scientific knowledge associated with advanced medical research in accessible form.
- 14. Depending on the epidemiological situation, the conference may end with the Closing Banquet more information will be given when the registration process closes.

III. Scientific papers and their authors

- 1. In all sessions, except the "PhD session", authors have to be students or within one year after graduation.
- 2. Only original research papers and case-reports (scientific press, literature, conferences), will be accepted. Research registered at the Conference cannot be a part of a doctoral (Ph.D.) thesis or habilitation, with the exception of the "PhD Session".
- 3. The author must choose one session from the list for the submitted abstract. The author holds the responsibility for the improper submission of the work. If the jurors find that the subject of the abstract does not correspond to the topic of the session, the abstract will be rejected. Changes of the session are possible only in case of author request before the deadline of the abstract submission.
- 4. All case-reports shall be submitted only for Case Study Session. Case-reports presented in other sessions than the "Case study" session will not be considered for the awards for best presentation. If the case-report was submitted to the other session by mistake, the session specified in the submission can be changed on the Author's request. If the case-report was submitted to the other session, and was not reported by the Author nor recognised by the Organizing Committee, the Author holds the responsibility for the improper submission of the work. The presentation of the case-report in other sessions than "Case study" session

- will still be granted the certificate of participation, as any other presentation of Juvenes Pro Medicina Conference, but will not enter the contest for the best presentation in the session, and thus cannot be awarded the prize.
- 5. Papers based on literature (reviews) will be rejected from the scientific part of the Conference.
- 6. Each participant of the Conference may register up to 2 abstracts (i.e. 2 original papers, 2 case studies, one original paper and one case study, or one original paper or case study and poster). For each accepted abstract submission, the participant will receive a certificate of participation. This rule applies to the presenting authors. The author, who is presenting two works, may be a co-author in other abstracts presented by the other people.
- 7. Registration of abstracts is based on submitting an abstract (in English) via the form on the website the deadline of abstract submission is the 15th of March 2022, 23:59 CEST. In specific cases, this deadline may be extended as needed by the Organizers.
- 8. The abstract should not be longer than 3000 characters including spaces. The abstract must consist of 5 parts (introduction, aim of the study/purpose, material and methods, results, conclusions). For case reports, the abstract should consist of an introduction, case report, and discussion/conclusion.
- 9. The abstract of the original work (regardless of progress of research) must contain results and conclusions it is unacceptable to use assertions such as "Our results will be presented at the Conference". The abstract cannot contain grids, graphs or picture images. Abstracts violating this regulation will be strictly rejected.
- 10. Abstracts registered to the Conference are reviewed by the Scientific Committee of the Conference in order to verify the correctness of the submitted abstracts and decide either to accept or reject the abstract. Moreover, the Scientific Committee qualifies accepted abstracts to the appropriate scientific session.
- 11. Decisions of the Scientific Committee will be published no later than 15th of April 2022. The decisions are final.
- 12. Each scientific paper can be presented and discussed by ONLY ONE of the authors indicated in the registration process
- 13. Authors, who do not fulfill criteria stated in point 1, will be automatically moved to the tutor section.

V. Principles of presentations

- 1. Original Research Sessions and PhD Session
 - Original papers and PhD sessions will be held on May 12 and 13, 2022, on -site. Authors
 meeting the conditions of §2.3 may participate in the online session.
 - Presentation requirements: English, file format: PDF or PPTX.
 - The time allotted for presentations is 10 minutes (7 minutes for student presentations and 3 minutes for discussion).
 - Works will be assessed according to the rules set out in §6 and the best works of the Original Works Sessions (excluding PhD Sessions) will be eligible for the Plenary Session.
 - The plenary session will be held on May 14, 2022. The Organizing Committee of the Conference will contact the people who won first place on the day of the respective sessions. Confirmation of participation in the plenary session should be sent back by 9:00 PM CEST on the relevant Original Works Session.
 - The presentation time in the Plenary Session is 13 minutes (10 minutes for the student presentation and 3 minutes for the discussion).
 - The presentation for the plenary session may be extended with additional slides.

2. Case Study Sessions

- Case Study Sessions will be held on May 12-13, 2022. online.
- Presentation requirements: English, file format: PDF or PPTX.
- Online sessions will be held through the ZOOM program or the Conference Platform.
 The Organizing Committee will inform about the exact details closer to the date of the event.
- The time allotted for a presentation is 8 minutes (6 minutes for a student presentation and 2 minutes for a discussion).
- The works will be assessed in accordance with the rules set out in §6.

3. Poster Session

- The poster session will take place on May 14, 2022 on-site at the Clinical and Didactic Center of the Medical University of Lodz.
- The author of the poster is required to print it with the following requirements: size A1, horizontal layout.
- The time allotted for a presentation is 8 minutes (6 minutes for a student presentation and 2 minutes for a discussion).
- The works will be assessed in accordance with the rules set out in §6.
- 4. Multimedia presentations may be prepared using any application. The author of the presentation is responsible for correct functioning of the presentation during the on-line video communication. We recommend the use of Microsoft Office PowerPoint or Adobe Reader. Video recordings included in the presentations are not recommended and their correct display via internet connection cannot be guaranteed.
- 5. All presentations must be delivered using an online method described in the qualification email. Organizers are not responsible for any problems from the participant side.
- 6. Each online session will hold an "demo" event, during which internet connection and short instruction for the authors will be provided. We encourage all the authors to take part in the "demo" to ensure proper connection during the session. In the event of connection problems from the authors side, we recommend contacting the University IT Department specific for the authors residency.
- 7. Online active participation: presentations will take place according to a precise schedule set by the Organizers. The schedule will be shared with participants at least 14 days prior to the conference. Mail confirmation of presenting authors availability according to the sessions schedule is required at least 7 days prior the conference. Further details for on-line presenting authors will be provided in the email information from the session coordinators. Each Case Report Session will be divided into 3 parts. Each author is obligated to login for

the online video communication room specific for the part of the session at least 10 minutes prior to the session start. Rooms will open 20 minutes prior to the beginning of the session, and the link for access to the video communication room will be sent on the email address specified in the abstract submission panel. The condition for admission to the room is a set nickname in the form of the name and surname entered in the abstract application.

- 8. Presentations in all sessions are held in random order. If the person is not present at the scheduled time of the presentation, the presentation is moved to the end of the queue. If there is no presenting author at the end of the session, the abstract is disqualified.
- 9. Exceeding the time of presentation results in getting negative 5 points. In case of exceeding the time by more than 5 minutes, the Coordinator can pause the presentation in this case, discussion does not take place.
- 10. There can only be one presenting person for a given scientific paper one of the authors must be indicated in the registration process
- 11. Tutors and co-authors are not allowed to participate in the discussion participation of a tutor or co-author will result in deduction of 5 points.

VI. Jury and awards

- 1. Presentations will be judged by a Jury properly selected for each scientific session. Tutor of a paper submitted to the Conference cannot be a member of the Jury. Before the start of each scientific session, the Jury selects the Chairman of the Jury from its members.
- 2. Presentations will be judged by the Jury on a scale of 0-5 in the following categories:
 - structure of the presentation,
 - aim and background of the presentation,
 - correct selection of the methodology,
 - presentation of the results, its discussion and the correct drawing of conclusions,
 - correct answer to the questions,
 - general performance.

From the final score determined by the Jury, Coordinator of the session subtracts points for exceeded time of presentation. Assessment of the Jury is final.

- After the end of each scientific session, protocol shall be drawn up. Protocol (with the
 detailed results of the session) is confidential and will not be published in any form to avoid
 violation of the privacy policy. All requests concerning publication of the results including
 personal information of participants will be automatically rejected.
- 4. In Each session 3 best works will be chosen (1st place, 2nd place, 3rd place). The criteria used for ranking will be specified by the jury's opinion. In a situation where two or more presentations have the same score, the Chairman of the Jury of the session has a casting vote.
- 5. Physical prizes will be awarded to the 1st through 3rd place only in case of in person form of presentation. Online participant winners will recieve only a certificate. All the high-ranking authors (1st to 3rd place) will get the certificate of the best work within the session, all the authors will get the certificate of the active participation in the scientific competition.
- 6. 1st place authors from each Original Research Sessions have the opportunity to take part in Plenary Session. Sponsor of main prizes in Plenary Session is **FUMED The Foundation of Medical University of Lodz**. 1st to 3rd place will be awarded by a one-time scholarship in the amount of 200€ and an opportunity to present their outcomes in the Lecture Session. The prize will be sent by bank transfer after the Conference. The condition for receiving the prize is to provide the data necessary for the transfer in the reply to the informational e-mail.

VII. Final clauses

 During the Conference, organizers can provide accommodation booking or hosting opportunities. For this purpose, please contact the organizers via the contact information available on the website.

- Authors and their tutors agree to sharing and processing of data provided during the registration and publication of the abstracts and results of the Conference on the websites of the Medical University of Lodz, the Conference and STN and in the published conference proceedings.
- 3. Abstract book will be published by the Publishing House of Medical University of Lodz in online form.
- 4. Registration of abstract is tantamount to accepting this regulation by authors and their tutors. Authors of scientific works who fail to comply with the regulations may bear their consequences.
- 5. If the Conference does not take place for reasons attributable solely to the organizers, the organizers will entirely refund the fee to bank accounts designated by the Participant.
- 6. If the Conference does not take place for reasons beyond the control of the Organizers ("force majeure" e.g. flood, hurricane), the participant may not be able to get any compensation or reimbursement of fees associated with participation in the Conference.
- 7. The organizers are not responsible for personal belongings of participants that can be lost, damaged or stolen during the Conference.
- 8. Participants assume liability for destruction they made on the premises, where any activities related to the Conference are carried out.
- 9. Interpretation of these regulations and settlement of any problems which are not included in regulations should be resolved by the Conference Coordinator, in consultation with the Organizers.

These regulations become effective on the date of its entry on the official website of the Conference.
